

The CEO has repeatedly assured Council that our finance/audit committee is operating as it should be. Council has twice resolved unanimously (on 16/12/2015 and 19/10/2016) that we receive audit committee training. Last year's resolution was to invite "The Department of Local Government to come to the Finance/Audit committee to discuss the Local Government Operational Guidelines Number 09 – Revised September 2013, Audit in Local Government the appointment, function responsibilities of Audit Committees. Today the CEO has advised the training will occur before next month's meeting.

The CEO provided the following information to Council in his November Forum Report.

Council's list of borrowings with security over its Reserves Term Deposit of \$1,000,000 is listed as follows:

Loan No 111 Community Sport Centre \$1,210,000 Loan No 112 Advance Cash \$1,250,000

Council's legal advice from Jackson McDonald is attached, advising Council it is not precluded by Section 6.21 (2) of the LG Act from granting security interest over those reserve accounts within the term deposit that wholly contain "general funds".

The resolution requested a list of all our borrowings and our security used against each loan, not only which loans used reserve funds for security. The 2012/13, 2013/14 and 2014/15 Annual Financial Reports didn't have any disclosures in relation to collateral.

Purpose of Report

Council to make its final adoption of Councillor Representation in reducing the number of office of Councillors from nine (9) to seven (7) to take effect from Council Elections in October 2017.

Background

Council has previously adopted a Resolution as detailed below at Council Meeting held 17th February 2016:

"Moved Cr Haywood, seconded Cr Kingston that Council amend its composition structure of the number of Councillors from 9 to 7 to commence from the October 2017 Council Elections. CARRIED BY ABSOLUTE MAJORITY 8/1"

The below advertisement was placed in the West Australian Newspaper on Wednesday 21 September 2016 inviting Public Submissions closing at 12 noon on Thursday 3rd November 2016:

Shire of Goomalling Review of Councillors' Representation

In accordance with Schedule 2.2 of the Local Government Act 1995, the Shire of Goomalling has decided to retain its one district (no wards) but to consider in reducing the number of offices of Councillors.

Council invites public participation in the review to reduce the number of offices of Councillors from nine (9) to seven (7) Councillors.

The Review is being carried out against the following factors:

- Community of interest
- Physical and typographical features
- Demographic trends
- Economic factors
- Ratio of Councillors to electors in the current situation against the proposed one.

An important sheet/discussion paper is available outlining the current situation with the proposed implementation of seven (7) Councillors.

Public submissions are invited and are to be addressed to the following by Thursday 3rd November 2016 at 12noon.

Comments and details

No submissions were received and it is my recommendation to adopt Council's Councillor Representation reduction from nine (9) to seven (7) Councillors.

Implications to Consider

Consultative

The Public were invited to make a submission on the proposal. No submissions were received after more than six (6) weeks of the Notice's publication and advertisement including the Notice and documentation being on Council's website for the same mentioned period.

Strategic

The reduction of Councillors from nine (9) to seven (7) will reduce the cost of maintaining seven Councillors from nine Councillors and the estimated cost reduction is approximately \$7,500 per annum. It is also viewed that decision making process will be more effective and efficient if the number of Council Members is reduced.

Policy Related

There is no policy of Council appertaining to this matter other than the decision being made by Council.

Financial

Other than the reduction in cost to Council with the reduced number of Councillors, no financial implications are affected either to Council or staff.

Legal and Statutory

This process is legally required under the Local Government Act 1995.

Risk

It is viewed that there are no risks, as there is a state wide trend in reductions in the number of elected members and many local governments have found that fewer elected members has improved their decision making process.

Nature of Council's Role in the Matter

Executive Legislative

Purpose of Report

To approve the sale of 14 High Street, Goomalling to Miss Kirsty Beck for \$195,000 is carried out under the requirements of Section 3.58 of the Local Government Act 1995 which have been fulfilled to the stage of Council resolving its decision.

Market Valuation was assessed 6th October 2016 by Licensed Valuer.

Background

Kirsty Beck made an offer to Council to purchase 14 High Street, Goomalling for \$190,000 which was discussed by Council at its 19 October 2016 Council Meeting.

As Council had received a Market Valuation of the property for \$195,000, Kirsty was advised and therefore increased her offer to \$195,000.

The Notice of Intention to Sell Property, Lot 146 (14) High Street, Goomalling was advertised in the Goomalling Endeavour and West Australian Newspapers on 26th October 2016 with written submissions invited in regard to the proposed sale closing 12noon on Thursday 10th November 2016.

By the close of submissions, no submissions have been received.

Comments and details

It is my recommendation that Council approve the sale of 14 High Street, Goomalling to Miss Kirsty Beck for the Market Valuation of \$195,000 on an as is basis.

Implications to Consider

Consultative

As required by Section 3.58 of the Local Government Act 1995, the Public were invited to make a submission on the proposal. No submissions were received by the close.

Strategic

To provide suitable housing for sale not only to reduce housing stock and maintenance expenditure, but to increase rate revenue collection from outside source.

Financial

The sale of property will increase Council revenue and its proceeds will assist Council to reduce its loan debt.

Nature of Council's Role in the Matter

Executive Legislative

Purpose of Report and Background

To completed the last requirement of the Department's Probity Report, Council is required to adopt the submitted Financial Recovery Plan with the intention of extinguishing Council's loan debt of \$1,250,000 which was raised on the 4th January 2016.

Implications to Consider

Strategic

The proposal to sell a number of Council properties to extinguish the loan debt of \$1,250,000 is achievable as detailed in the Financial Recovery Plan which no doubt is dependent on market conditions but it is viewed that this is achievable by extinguishing the loan on 30th June 2020.

Policy Related

No policy of Council appertaining to this matter.

Financial

To reduce Council's loan debt of \$1,250,000 by selling a number of properties by June 2020, subject to complying with statutory requirements of the Local Government Act 1995.

Risk

The risk is the reliance of property sales in a low economic cycle, however Council is selling one of the properties detailed on the Financial Recovery Plan, which will reduce Council's loan debt of \$1,250,00 down to \$1,055,000 on 31st December 2016.
